## FUELBELT IN-STORE DISPLAY AGREEMENT

FuelBelt, Inc. has agreed to provide your store with a FuelBelt In-Store Display. (Either the Horizontal Hydration Station, the Vertical Hydration Station or the Pole Vault Display.) The In-Store Display should allow you to showcase FuelBelt products in an attractive manner. FuelBelt, Inc. requires that each Dealer who purchases or receives a FuelBelt In-Store Display agrees to the terms and conditions below.

The terms and conditions:

- 1 FuelBelt has agreed to provide the Display at no charge in conjunction with the 2005 Booking Program and/or the 2005 Preferred Dealer Program. In situations where the Dealer does not wish to subscribe to either program, the Dealer can purchase the Display at the assigned cost as per this Order Form.
- 2 The Dealer shall not at any time hold FuelBelt, Inc. liable for any form of rent or lease associated with hosting the Display in their stores nor shall FuelBelt, Inc. be obligated to provide any favorable commercial terms beyond the listed 2005 wholesale price of FuelBelt products.
- 3 The Dealer agrees to fully utilize the Display and shall agree to return the Display unit at the Dealer's expense if he/she deems that the Display unit cannot or will not be used in the Dealer's store.
- 4 The Dealer agrees to maintain the Display in an acceptable manner and furthermore agrees that he/she will not alter, embellish, modify, paint, dismember, or neglect the Display in any way.
- 5 Each Display contains a certain number of accessories included at no charge (see first page of Order Form). Additional accessories for the Display units are also available for Dealers at a nominal charge. These accessories include C-Band Slat Wall Hooks, C-Band Posts, Wood Signs and Slat Wall Hooks.
- 6 The Dealer agrees that only FuelBelt products will be showcased on the FuelBelt Display.
- 7 In the event that it is discovered that other products are shown on the Display, FuelBelt, Inc. reserves the right to have the Display removed immediately from the Dealer's store at the Dealer's expense. The Dealer agrees to pay for packaging and shipping charges associated with the removal of the Display from his/her store. FuelBelt, Inc. also reserves the right to suspend any further shipments to a Dealer who violates this Agreement.
- 8 Shipping for the Display by UPS will be paid for by the Dealer after the Booking Period dated April 30, 2005.
- 9 Delivery of the Display shall be on an "as available" basis and FuelBelt, Inc. reserves the right to not have the Display in stock for a temporary period not to exceed 90 days.
- 10 Signature of the front page of this Order Form and Agreement implies a complete and thorough understanding of these terms and conditions associated with the FuelBelt Display Agreement.
- 11 Limit One Free Display Unit per Store Location. Additional units can be purchased at the special dealer price listed on the Order Form.
- 12 C-Bands are to be used for FuelBelt products only.
